



## **Transition Incentive Program**

### **Subsection t Solar Facilities Seeking an Extension**

***Subsection (t) solar facilities are defined under N.J.S.A. 48:3-87 (t) as Solar Generation Facilities on Brownfields, Areas of Historic Fill and Properly Closed Sanitary Landfills.***

Per [Board Order](#) dated August 17, 2022, Subsection (t) projects conditionally certified and registered in the TI Program may be eligible to receive up to two (2) six-month extensions to their existing deadline established at N.J.A.C. 14:8-10.4(e) or (f), subject to the TI Program administrator's review and approval of an extension request. Any project developer that believes it is thus eligible for a waiver of the Board's rules may, at its election, apply to the Board's TI Program administrator, TRC, through a request submitted prior to the project's TI Program expiration date.

This request must be supported by the documentation listed in the below checklist:

- A **cover letter** stating the intention to complete the project within the TI Program and summarizing the status of project development
- A completed **Subsection t Milestone Reporting Form**, which documents progress made toward completion and the dates anticipated for achievement of remaining milestones
- Copies of **all interconnection-related correspondence between the project and PJM Interconnection** and its agents, including any interconnection applications, any draft or executed study agreements, evidence submitted to meet PJM milestones, and any other interconnection materials or correspondence between the project developer and PJM, the relevant agent, or utility
- Evidence that all required **federal, state, or local permits** have been applied for with the authority having jurisdiction.

**This Milestone Reporting Form must be submitted by the Applicant with the initial extension request and an updated form showing the progress of the solar installation must be submitted every three months following the date the extension request was granted. ### **Solar Facilities Seeking a Second Extension**

For Subsection t solar facilities seeking a second six-month extension, you must file a second extension request and provide satisfactory evidence to the TI Program administrator, TRC, that the project is making progress towards completion and is reasonably likely to meet its revised expiration date noted in the revised acceptance letter.

This 2<sup>nd</sup> extension request must demonstrate sufficient progress toward completion and be supported by documentation listed in the below checklist:

A **Subsection t Milestone Reporting Form** that demonstrates progress made toward completion and the dates anticipated for achievement of the remaining milestones

**Photos** demonstrating progress toward completion of the project.

**Purchase orders, work orders, solar developer contracts,** or similar evidence that the revised date remains feasible in addition to the requirements

**This Milestone Reporting Form must be submitted by the Applicant with the 2<sup>nd</sup> extension request and an updated form showing the progress of the solar installation must be submitted every three months following the date the 2<sup>nd</sup> extension request was granted. The Milestone Reports showing the progress of the solar installation should be submitted to the TI Processing Team at [njreinfo@njcleanenergy.com](mailto:njreinfo@njcleanenergy.com).**

**NOTE:** *The Board FINDS that any given project may only qualify for one blanket extension. For example, a project qualifying for an extension under this Order would not also be eligible for the up to two (2) six-month extensions authorized for public entity projects as discussed in a companion order in this docket. Instead, the project may select which of these extensions it wishes to avail itself of.*
